## **R4JUST: Radicalisation Prevention Competences Development Programme for Justice Professionals**

The **R4JUST “Radicalisation Prevention Competences’ Development Programme for Justice Professionals”** project aims to prevent and reduce the risk of radicalisation and violent extremism inside prisons by exploring a multi-sectoral approach, intending to enhance the competences of prison staff, probation staff (e.g., probation officers/supervisors, psychologists), as well as judges and prosecutors while fostering criminal and judicial multi-sectoral cooperation and networking on countering and preventing radicalisation.

The [R4JUST project](#) has developed a specialised b-learning training course for judges and prosecutors across the EU, to be piloted across 5 different countries (Italy, Portugal, Romania, Poland and Germany).

### **WHO?**

The training is designed for, and available to, judges and prosecutors.

### **WHAT?**

Training will support judicial staff in the application of radicalisation risk assessments, helping to identify and respond to prisoners who are, or are becoming, radicalised at a sentencing level. The aim is to make the process as effective, unbiased and easy to use as possible, in order to minimise the phenomenon of radicalisation in all its colours within the prison environment, while protecting the rights of prisoners. Modules 1 and 2 of the course will also be available to prison and probation staff, helping to harmonise how radicalisation is understood and responded to across professions. Modules 3 and 4 are dedicated to the specific challenges and opportunities facing judges and prosecutors, focussing on data protection and privacy when preventing and countering radicalisation in prison





(Module 3) and judicial procedures for inmates under observation for radical behaviours (Module 4).

The modules and key topics are as follows:

<b>Module 4</b>	<b>Judicial Procedures for inmates under observation for radical behaviours</b> The policy debate around the radicalisation-terrorism nexus Hybrid dynamic between pre-crime and crime Radicalisation at preventive and sentencing level Alternative programmes and restorative justice

## WHEN?

The course is structured to make participation in the training and possibilities to boost your career progression as easy as possible. For this reason the training will be **self-paced** and **online**, meaning you can do it **when you want, where you want** and **how you want**. Training modules will be released gradually, with the first module being released in April 2022. You can spread your time from then until May 2022. Each time a module is released we'll send you an email alert, just to keep you updated.





## WHY?

As a judicial practitioner, you are well aware of the impact of sentencing and rehabilitation decisions on inmates. Addressing the issue of radicalisation in prison specifically, the R4JUST training will equip you with the **skills and tools** to contribute to sentencing decisions that avoid the exacerbation and proliferation of radicalisation towards violent extremism. This includes ensuring that inmates have access to appropriate and timely rehabilitation and resocialisation schemes.

Modules 1 and 2 of the course will be based on the [R2PRIS](#) risk assessment toolkit, offering you the **highest level of skills, as implemented across the European Union**. On a personal level, the training will help support your **career progression** in a way that is flexible and that comes at no cost to you and your institution. At an institutional level, the training will ensure the highest standard of risk assessment and response among your staff, contributing to a more **harmonious and safer prison environment** for all involved. For prisoners and accused, having better trained judicial staff means that their needs can be better identified and met, putting them on the path for resocialisation and reintegration programmes best adapted to them.

## HOW?

To access the course, you will be given **exclusive access to the Corrections Learning Platform**. All modules will be hosted online through a-synchronic sessions, offering the maximum level of flexibility for your learning. No costs or selection criteria apply.
